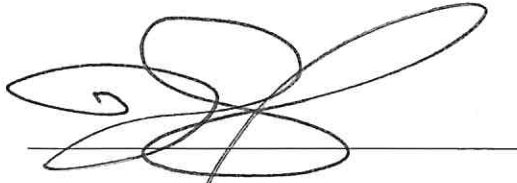

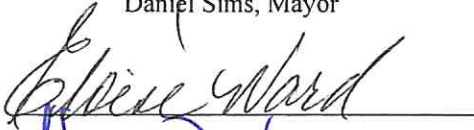
Citizens to Speak –

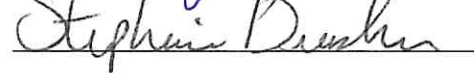
1. Kenneth Allison – Spoke on the Market study that was completed almost 2 years ago. Mr. Allison spoke with the council asking for the town to retain him for his services.
